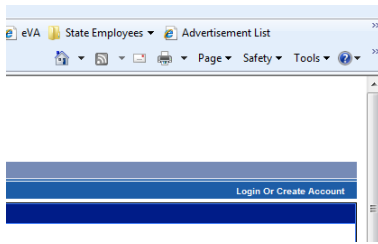

1. Login into CABB: <http://cabb.virginiadot.org/>



2. Scroll down to the current advertisement listing



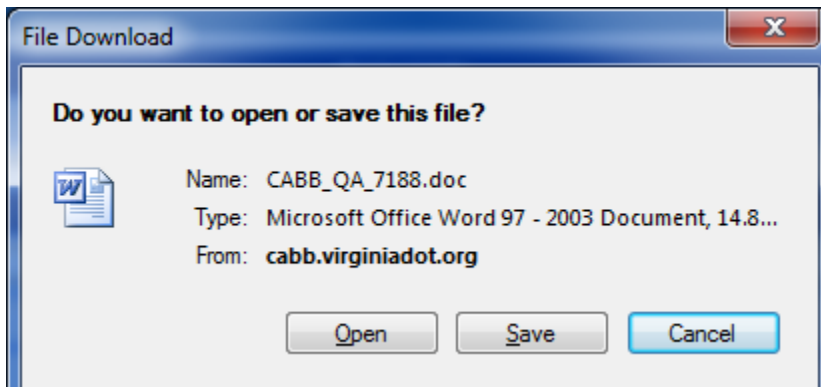
